What You Need to Know About the Pfizer/Moderna “Vaccines”

— We are not “anti-vaxxers.” This is not about being against all vaccinations.

— As of October 2021, over 18,000 deaths which are possibly-linked to the “vaccines”/injections have been reported to the CDC’s official Vaccine Adverse Events Reporting System (VAERS), and over 28,000 permanent disabilities.

– Both the Pfizer and Moderna products are still undergoing initial phase III human clinical trials for safety and efficacy, which are not complete until the end of 2022, at the earliest. **These are by definition still experimental.**

– According to the CDC, children under age 20 are at essentially zero risk of dying of COVID. Risk of dying from the shots may be more than three times the risk of dying from COVID for children. [17,000 vaccine deaths/150,000,000 fully vaccinated = .0001, or .01%. Risk of death from COVID for under age 20 is .003%]. — In the same study in Toxicology Reports, the scientists estimate that actual deaths from the Pfizer/Moderna injections may be in the “hundreds of thousands.”

— A US Army Flight Surgeon has grounded her air crew and filed a lawsuit in Federal District Court in Denver, under the Military Whistleblower Protection Act of 1988.
